# **Camp ASCCA Medication Policies**

# 2024 Update

- 1. Daily Scheduled Medication- Daily Scheduled Medication will be administered by designated medication passers. These medications MUST BE appropriately packaged in weekly blister pack/card. The medications packaged for the camper's week at camp MUST have a prescription label that is current, accurate, and matches the information that you entered into the camper's online application. Please always pack an extra dose of each medication.
  - All prescriptions should include patient name, medication name, dose, time, and route. Any prescription medication that arrives without appropriate labeling will not be accepted for distribution.
  - Prescription liquid medications, eye drops, inhalers, and powders, and any
    medication or supplements that are not in pill form must be brought in its original
    packaging with prescription label.

# **UPDATED POLICY:**

- Over-the-counter melatonin and vitamins DO NOT require a note from the doctor. These medications MUST be blister packed.
- 2. **PRN or "as needed" medications** will be given by camp nurses. PRN medications must be packed **separately** from Daily Scheduled Medications.
  - Over-the-counter PRN medications (i.e., Tylenol, allergy meds, etc.) that are brought to camp need to be in the original container and unopened with camper's name written on bottle.
  - Prescription PRN medications must have a prescription label that is correct and up-to-date on the packaging.
- 3. Medications may be packaged at home in approved blister cards with prescription labels attached. Please continue reading for precise instructions.
- 4. All medications must be updated in the camper's application within Camp Brain *PRIOR* to arrival to Camp ASCCA. It is the responsibility of the parent/caregiver to update any discontinued medications, new medications, and dosage changes that have occurred since the camper was registered for camp. Camp ASCCA will open the camper applications for each summer session 2 weeks prior to check-in. This will allow you to go to our website and log back into the camper application to update all medications. *You will receive am email reminding you to go in and make any corrections*.

# **At-Home Medication Packaging**

Medications may be blister packed at home in approved blister cards (links below). These medications must be packaged exactly according to the prescription label. Over-the-counter melatonin and vitamins MAY be packaged with daily prescribed medications. Prescriptions for daily prescribed medications (these are medications that doctors have written a prescription for) MUST be attached to blister card. Pharmacies will print your prescription labels for you, just staple or tape them to the blister back or put the labels in a bag with the blister card. CAMP ASCCA WILL NOT GIVE ANY DAILY PRESCRIBED MEDICATIONS WITHOUT PRESCRIPTION IN HAND.
